





CLEMENT A. PRICE HUMAN DIGNITY AWARD

Clement Alexander Price is a Board of Governors Distinguished Service Professor, Professor of History, and Director of the Rutgers Institute on Ethnicity, Culture, and the Modern Experience at Rutgers University, Newark Campus. A native of Washington, D.C., Dr. Price's career is marked by a blend of traditional and public intellectual work that brings scholarship and scholars to a cross section of citizens and communities in Greater Newark, New Jersey.

He was among the first scholars in Newark to dramatize the role of the public intellectual in ameliorating racial discord, shedding light on historical memory, dignifying the bittersweet narrative of African Americans in modern Newark's history, and leading public and private institutions toward a higher standard of public service.

Price began teaching history at RU-N in 1969. Rutgers appointed him Board of Governors Distinguished Service Professor in 2002, one of the university's highest faculty honors, citing his dedication "to the ideas of community, and his sustained impact on the development of cultural, civic, educational and academic institutions in the City of Newark and the State of New Jersey," as well as his "unwavering"

commitment to the communities in which he lives, and his concern for social justice."

At Rutgers Price filled many roles, as teacher, mentor, and advisor, and as director of The Rutgers Institute on Ethnicity, Culture, and the Modern Experience (IECME), which he founded in 1996. IECME has since become a model of public scholarship and engagement, by sponsoring numerous programs and research initiatives that foster broad public discussion on the arts and culture, urban life and development, diversity and race relations, education, and history at the local, national, and transnational levels.

CLEMENT A. PRICE HUMAN DIGNITY AWARD

Recipients of the Clement A. Price Human Dignity Award meets any or all of the following criteria:

- Amassed a body of work in research, community work, leadership, or teaching that has positively changed the relevant environment with respect to diversity, equity, inclusion, and access
- Has forged intercultural cooperation and collaboration among groups that have not ordinarily worked together
- Has demonstrated a sense of social responsibility that drives their work and motivates others; is respected as a role model and a changemaker
- Has reduced prejudice as a result of their work and created an inclusive community and climate of civility among students, faculty, and staff
- Has a proven history of developing sustainable projects at the university and in the relevant environment

The Clement A. Price Human Dignity Award is named after the late Rutgers' Board of Governors Distinguished Service Professor Clement A. Price, historian, and former chair of CACP. This award recognizes outstanding individuals who have demonstrated extraordinary achievement and commitment to promoting and practicing diversity, inclusion, equity, and access within the University and/or in partnership with community organizations.

LORI SCOTT-PICKENS

STAFF RECIPIENT OF THE CLEMENT A. PRICE HUMAN DIGNITY AWARD

Lori Scott-Pickens is currently the Director of Community Outreach for the School of Criminal Justice and has served as an Adjunct Professor for the SCJ. Born and raised in Newark, Scott-Pickens is one of 12 children. She attended several elementary schools around the city and is a graduate of Shabazz High School.

Recently, she was the Deputy Executive Director SCJ's Police Institute. The Police Institute served as the Neutral Convener for several community and law enforcement collaborations; the Greater Newark Safer Cities, the Serious and Violent Offender Re-Entry Initiatives, Operation Cease-Fire, the Gun Strategy, Newark Violence Reduction Initiative, and four of the five Fugitive Safe Surrender programs held in NJ; Newark, New Brunswick, Atlantic City and Jersey City where NJ leads the nation in serving more than 17,000 participants.

Ms. Scott-Pickens has an extensive background in community organizing at the local, state and national levels where she has provided consultation and technical assistance. She is the cofacilitator of the Juvenile Justice Reentry Initiatives in Essex County where she serves as a Commissioner and is a member of the Youth Services Commission's Multi-Disciplinary Team. She also served as Co-Chair of the statewide Juvenile Re-Entry Coordinating Council. She works closely with various levels of government, faith-

based institutions, residents, and community-based organizations around Restorative Justice, Community-Policing and Prisoner Re-Entry efforts where she also serves in an advisory capacity.

Scott-Pickens has worked for some of Newark's premiere non-profit organizations; the Advocates for Children of New Jersey, Unified Vailsburg Services Organization, Newark Fighting Back Partnership Inc. and Community Agencies Corp of NJ and a member of the National Organization of Black Law Enforcement Executives (NOBLE) and a Board President, of the Newark School of the Arts. She has also held positions in both state and local government.


Ms. Pickens is a committed community advocate for children and families and has been involved in the development of several publications, grants and articles on behalf of the Newark's children and families. She served two terms as co-chair of the Essex Vicinage's Advisory Committee on Minority Concerns.

In addition, she has also been a Board Member of the US Department of Justice's COPS Office's Policing Resource Advisory Board appointed by the then Clinton Administration. She is an active member of various organizations involved in criminal and social justice on both the local and national levels.

Ms. Scott-Pickens has received numerous awards and recognitions for her work and holds a BA in Sociology from Montclair State University a MA Degree in Public Affairs and Administration from Rutgers University.

In recognition for exceptional work and long-term service as a champion of diversity, equity, and inclusion at Rutgers University and abroad in supporting healthy communities and for teaching students to broaden their understanding of themselves and the populations they serve.

Peter J. Guarnaccia (Ph. D., Connecticut, 1984) is a Professor in the Department of Human Ecology at the Rutgers School of Environmental & Biological Sciences and an Investigator at the Institute for Health, Health Care Policy & Aging Research in Rutgers Biomedical Health Sciences. His research interests include crosscultural patterns of psychiatric disorders, cultural competence in mental health organizations, and processes of cultural and health change among immigrants.

He has examined mental health among Latinos in the U.S. and in Puerto Rico for three decades, most recently using the National Latino and Asian American (NLAAS) mental health study funded by National Institute of Mental Health. He was Associate Editor of Culture, Medicine and Psychiatry from 2000-2004 and Co-Editor-in-Chief from 2004-2007. He is coeditor, with Keith Wailoo and Julie Livingston, of A Death Retold: Jesica Santillan, the Bungled Transplant, and Paradoxes of Medical Citizenship (2006).

Prof. Guarnaccia directed one of the Rutgers Global Service Learning Programs on Culture and Community Health in Oaxaca, Mexico from 2009-2018. He formerly directed Project L/EARN, a program at the Institute for Health, which trains underrepresented undergraduates for careers in health research (1996-2008). He recently published Immigration, Diversity and Student Journeys to Higher Education (Peter Lang, 2019), based on a study of immigrant students at Rutgers that was funded by National Institute of Child Health & Human Development (NICHD).







TEHYLA MCLEOD'S ARTIST WORK STATEMENT

Through my recent art practice, I've been working on creating a program called All your HeART which focuses on using art as a form of enjoyment, art therapy, and love in the homeless community in downtown New Brunswick. Mainly through drawings, I focus on capturing and honoring my subjects through the intimacy of observation, conversation, and vulnerability. The premise of my paintings are two-sided: they are gifts given to my subjects (of whom I rather call my friends) and they are powerful biographies of our invisible

community members. My paintings represent the homeless through the exploration of color relationship, figuration, and "perception". With little political agenda, my work highlights the humanity of the homeless without making obvious their misfortunes. With much influence from Alice Neel, Ernst Ludwig Kirchner, and contemporary figurative artists like Kehinde Wiley, Agnes Grochulska, and Aliza Nisenbaum. I look to educate and storytell with art.






EMMANUELLA MACRI'S ARTIST WORK STATEMENT

This poem describes my feelings towards the Rutgers community, and centers on my own unique identity as an extremely introverted, quiet person.

Throughout my life, I have always really struggled with making friends and feeling like I fit in. I usually prefer to observe rather than socialize, which makes me feel like an outsider rather than a part of the group, for any setting I find myself in.

However, from the moment I got to Rutgers, I felt the wonderful feeling of being a part of something, and that feeling has only grown stronger over time. This poem centers on the juxtaposition of myself being apart from others, observing the Rutgers community around me, while feeling contentment knowing that I am a part of this beloved community.



The goal of the podcast is to help spread knowledge and awareness about Social-Emotional and Character Development (SECD), an educational and pedagogical framework that involves skills such as perspective-taking, social awareness, and emotional regulation; and character virtues such as generosity, forgiveness, and positive purpose.

The proposed project aimed to expand our SECD on Demand podcast to include guest speakers that are members and leaders from different communities and organizations at Rutgers University - including Rutgers Career Services, Residence-Life, Counseling, Alcohol and Other Drug Assistance Program & Psychiatric Services (CAPS), Rutgers University Student Assembly, as well as the Cultural Center Collaborative. In doing so, we aimed to foster collaborations between our team and the wider Rutgers community.





This project directly engaged ~150 students in exploring the idea of beloved community for the full 10 weeks of Honors Colloquium. Panel discussions featured scholars from across the university that helped students build a multi-disciplinary framework for examining community and inclusivity. Small discussions guided by Honors Colloquium Facilitators helped students use that framework to cultivate their view of beloved community at Rutgers. To broaden engagement, the SAS Honors Program collaborated with Art Librarian, Megan Lotts, to organize a public exhibition of the student works in the Rutgers University Art Library Exhibition Spaces (RALES). The "Images of a Beloved Community" exhibition opened on April 6, 2022 as the culmination of Honors Colloquium, and will run through the end of summer 2022. The artworks themselves, and the accompanying exhibition catalog prepared by students, invites members of the university community to see how students experience the rich tapestry of Rutgers. The exhibition provides a visible and visual statement of the value that Rutgers students place on beloved community.


